



January 20, 2026

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Tuesday, January 20, 2026, with Chairman Harris presiding. The agenda was posted outside in the Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Dr. Art Sixkiller, Mr. Mark Roberts and Ms. Lorri Mitchell.

Ms. Violet F. Kirkendall of Hood & Associates CPAs, PC was in attendance.

Mr. Jared Crisp reported no changes or additional comments to the written annual Identity Theft Prevention Program Red Flag Alert Policies and Procedures Report prepared by Mrs. Josi Morrison.

A motion was made by Dr. Rains and seconded by Ms. Mitchell to approve the minutes of the Regular Meeting held on January 05, 2026. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, Roberts, and Mitchell Nay – none

The Board recognized Mr. Jared Crisp, who presented the claims for approval.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #0774 - #0831 totaling \$981,050.43 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, Roberts, and Mitchell Nay – none

Honorable Mayor Doyle was absent.

The Board recognized Ms. Violet F. Kirkendall of Hood & Associates CPAs, PC who presented the Annual Audit for Fiscal Year ending June 30, 2025. There were no Audit Findings and the Reserve for Extension Capital Improvements was increased by \$193,800 for a new total of \$1,606,908. The Total Net ending position for Fiscal Year ending June 30, 2025 was \$45,358,053.

A motion was made by Dr. Rains and seconded by Dr. Sixkiller to accept the Annual Audit for Fiscal Year ending June 30, 2025 as presented. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, Roberts, and Mitchell Nay – none

Mr. Jared Crisp provided an update on the Extension of the MUB Natural Gas Pipeline Project east of town. He also shared that the Nipak Lift Station is scheduled to arrive later this week. Additionally, the 18-inch Sewer Line Replacement Project at SE 17th Street and Marietta Street is scheduled to begin the week of January 26, weather permitting.

Mr. Jared Crisp also presented a comparison of rates among other electric companies to illustrate the differences between the MUB's proposed new rates and the current rates in the surrounding area.

Mr. Jared Crisp discussed and recommended adopting the Local Government Testing Consortium Member Agreement for Calendar Year 2026. Local Government Testing Consortium (LGTC) administers and monitors the Municipal Utility Board's (MUB) pre-employment, post-accident and random drug testing program.

A motion was made Ms. Mitchell and seconded by Dr. Sixkiller to adopt the Local Government Testing Consortium Member Agreement for Calendar Year 2026. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, Roberts, and Mitchell Nay – none


Mr. Travis Willis reported on New Truck #10 and Truck #1A.
