



December 15, 2025

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, December 15, 2025, with Chairman Harris presiding. The agenda was posted outside in the Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Dr. Art Sixkiller, and Mr. Mark Roberts; Ms. Lorri Mitchell was absent.

No guests were in attendance.

A motion was made by Mr. Roberts and seconded by Dr. Rains to approve the minutes of the Regular Meeting held on December 1, 2025. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, and Roberts; Nay - none

The Board recognized Mr. Jared Crisp, who presented the claims for approval.

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to approve Claims #0641 - #0701 totaling \$1,047,553.64 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Harris, and Roberts; Nay – none

Honorable Mayor Doyle was absent.

Mr. Jared Crisp reported that the generator at the Wastewater Treatment Plant is up and running. He also reported that another bus bar burned up at the Wastewater Treatment Plant over the weekend and that a temporary repair has been made until it can be replaced. Replacement of the bus bar would require the Plant to be shut down for up to three days. Additionally, he reported that he is consulting with the engineer to obtain cost estimates for bringing the existing headworks at the Wastewater Treatment Plant into compliance with Oklahoma Department of Environmental Quality (ODEQ) requirements.

Mr. Jared Crisp discussed and recommended approval/authorization for Chairman Harris to execute release of a blanket easement for a water line in the SW/4 of Section 35, Township 21 North, Range 19 East, in exchange for a defined easement from the current property owner.

Mr. Jared Crisp discussed recommending to the Pryor Creek City Council an increase in water rates inside city limits from \$5.27 per 1,000 gallons to \$5.45 per 1,000 gallons, with the minimum in accordance with the rate, effective January 2026 billing. This would increase the monthly bill by approximately \$0.90 for a typical customer with average water consumption (5,000 gallons).

A motion was made Dr. Rains and seconded by Mr. Roberts to recommend to the Pryor Creek City Council an increase in water rates inside city limits from \$5.27 per 1,000 gallons to \$5.45 per 1,000 gallons, with the minimum in accordance with the rate, effective January 2026 billing. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Rains, and Harris; Nay – none

Mr. Jared Crisp discussed recommending to the Pryor Creek City Council an increase to the residential electric rate inside the corporate city limits from \$0.0810 per kWh to \$0.0830 per kWh, with the minimum in accordance with the rate, effective January 2026 billing. This would increase the monthly bill by approximately \$2.00 for a typical customer with average electric consumption (1,000 kWh).

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to recommend to the Pryor Creek City Council an increase to the residential electric rate inside the corporate city limits from \$0.0810 per kWh to \$0.0830 per kWh, with the minimum in accordance with the rate, effective January 2026 billing. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Rains, and Harris; Nay – none

Mr. Jared Crisp discussed and recommended approval/authorization for Chairman Harris to execute the Notice of Award and Contract to Lonehickory Cattle, LLC for the 17th Street Sewer Replacement (Pipe Bursting) Project at a price not to exceed \$109,500.00.

Mr. Travis Willis discussed implementing additional measures to prevent theft and enhance security at our locations. He is exploring an upgraded security system for the pole yard, with the potential for reimbursement through GRDA. In addition, options for replacing truck beds were discussed. Cowboy Rigs was identified as offering the most competitive pricing. The estimated cost is approximately \$7,000± and would include all necessary components to return the truck to a configuration equivalent to the previous setup, including a toolbox, lighting, and fuel tank.

A written Department Foreman's Report was presented with no additional comments.

There was no Unfinished Business or New Business to discuss.

Mr. Ben Sherrer was absent. Mr. Crisp stated that he is reviewing the Collocation Lease Agreement with Bluepeak Fiber.

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to adjourn at 6:49 p.m. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Rains, Sixkiller, and Harris; Nay – none
