

August 3, 2020

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, August 3, 2020, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Dr. Art Sixkiller and Mr. Mark Roberts.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held July 20, 2020. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts Mitchell, and Sixkiller. Chairman Harris abstained which counts as a no vote.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #69 - #122 totaling \$428,544.72 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Rains, Roberts, and Harris Nay – none

The Board recognized the Honorable Mayor Larry Lees who reported his work on the Budget for the City of Pryor Creek.

Mr. Steve Powell was unable to attend by video conference because of a malfunction on the Smart Board in the Board Room. Mr. Powell prepared a written report which Mr. Jared Crisp reviewed with the Board.

The Board recognized Mr. Jared Crisp who reported one (1) employee tested positive for COVID-19. The employee came in contact with seventeen (17) employees who were immediately quarantined at home and are utilizing the maximum 80 hours paid sick leave benefit required by FFCRA (Families First Coronavirus Mayes County Health Response Act). The Department recommended two test for the seventeen employees. The results from the July 29, 2020 test have all been negative. The second round of testing, to ensure that we do not have any asymptomatic (no symptoms) positives, is scheduled on August 5, 2020. If the second test is negative, then the employee will be cleared to return to work.
