

## January 6, 2025

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, January 6, 2025, with Chairman Harris presiding. The agenda was posted outside in the Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Dr. Art Sixkiller, Ms. Lorri Mitchell, and Mr. Mark Roberts.

Attending guests were the Honorable Mayor Zac Doyle, Mrs. Jennifer Adams, Mrs. Josi Morrison, and Mr. Terry Aylward.

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to approve the minutes of the Regular Meeting held December 16, 2024. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Rains, and Harris Ms. Mitchell abstained which counted as no vote.

The Board recognized Mr. Jared Crisp who presented the claims for approval.

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to approve Claims #0676 - #0724 totaling \$778,689.46 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Mitchell, Roberts, and Harris Nay – none

The Board recognized the Honorable Mayor Zac Doyle who reported a City Councilmember wanted the Municipal Utility Board to consider offering discounted utility rates for the City of Pryor Creek General Fund utility accounts.

Mayor Doyle also reported the incumbent City Clerk for the City of Pryor Creek, Mrs. Hannah Morris, was hired as the Assistant City Clerk and began her re-employment on January 6, 2025.

The Board inquired about the future of the Sertoma Senior Citizen Building to which Mayor Doyle reported he had a meeting scheduled with Sertoma Club Members to discuss future options and hoped to have something to report at the next meeting.

The Board recognized Mr. Jared Crisp for an Engineer's report and he reported if the weather permits the contractor, Reed Environmental, LLC, will be mobilizing equipment next week to the job site for the 9<sup>th</sup> Street Lift Station Improvements and Sludge Removal Project.

Mr. Jared Crisp also reported the transfer switch for the generator at the Wastewater Treatment Plant is still on backorder from the September 2024 estimated delivery date. The subcontractor, 2 J's Electric, has completed the prep work and is at a standstill until the transfer switch arrives.

Mr. Jared Crisp updated the Board on the Lift Station Projects.

Mr. Jared Crisp discussed the Oklahoma Corporation Commission's past and upcoming audit of the Gas Department and recommended the Board approve Resolution 2025-01 which is adopting the updated Pryor Municipal Utility Board's Anti-Drug and Alcohol Misuse Prevention Policy.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Resolution 2025-01 adopting the updated Pryor Municipal Utility Board's Anti-Drug and Alcohol Misuse Prevention Policy. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Roberts, Rains, and Harris Nay – none

Mr. Jared Crisp reported the Municipal Utility Board Safety Coordinator had scheduled an on-site mobile hearing test service at the warehouse on Wednesday, February 5, 2025 between 1:00-5:00 p.m. and extended an invitation to the Board Members and their spouses to participate in the testing.

Mr. Jared Crisp reported he was still reviewing the Oklahoma Ordnance Works Authority 2024 Water Treatment and Waste Treatment Financial Planning and Rate Study to show an updated five-year projection of rates beginning January 1, 2025. It appeared there would be a 2.50% increase every six-months for water rate (an annual 5% increase) and a 3.50% increase every six-months for waste rates (an annual 7% increase) until 2029. Mr. Crisp will prepare rate recommendations to the Board on Tuesday, January 21, 2025 for recommendations to the Pryor Creek City Council on February 4, 2025.

The Board recognized Mr. Travis Willis who reported he received supplies for MUB staff to use to repair the insulation on the new generator which was damaged by a raccoon at the Wastewater Treatment Plant. The supplies cost ±\$94.00 and the Caterpillar Salesman reported a warranty claim would cost ±\$10,000.00.

Mr. Jared Crisp reported the Purple Wave bids to date had already exceeded his expectations on the following surplus items and the auction would close on February 4, 2025.

- 1. 2016 Chevrolet Silverado 2500 4x4 Crew Cab with Service Body Serial No. 1GC2KUEG0GZ239991 (Truck #4). Currently \$6,500.00

- 3. 2017 Dodge Ram 2500 4x4 Crew Cab with Service Body Serial No. 3C6TR5HT5HG636328 (Truck #12). Currently \$5,000.00

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

Mr. Jared Crisp discussed and recommended the Board allow three (3) employees to attend the Oklahoma Municipal Assurance Group (OMAG) Severe Weather Expo in Shawnee, Oklahoma on February 25-26, 2025.

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to allow Mr. Jared Crisp, Mr. Travis Willis, and Mr. Ryan Stout to attend the Oklahoma Municipal Assurance Group (OMAG) Severe Weather Expo in Shawnee, Oklahoma on February 25-26, 2025 at a cost not to exceed \$600.00. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Mitchell, Rains, and Harris Nay – none

There was no Unfinished Business discussed.

Mr. Jared Crisp recognized the MUB Finance Director, Mrs. Josi Morrison, who will begin assisting with the recording of Municipal Utility Board Minutes in preparation for Mrs. Teri Hill's retirement.

The Board recognized Mr. Ben Sherrer who reported a Status Conference is scheduled for January 14, 2025 on the Declaratory Judgement Case Number CV-2024-26 "Municipal Utility Board and City of Pryor Creek, Oklahoma Petitioners, vs. Tyler Brown, et al".

A motion was made by Mr. Roberts and seconded by Ms. Mitchell to adjourn at 6:23 p.m. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Mitchell, Rains, Sixkiller, and Harris Nay – none
