

JULY 17, 2017

The Municipal Utility Board met in a Regular Session at 7:00 o'clock p.m. on Monday, July 17, 2017, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Robert Lindsey, Ms. Lorri Mitchell, and Mr. Mark Roberts. Dr. Art Sixkiller was absent.

Mr. Pruett reported Line #24 of Bid #902 increased \$113.02 because we received an additional 312.58 feet of wire and makes the new Bid #902 total \$39,613.99.

A motion was made by Ms. Mitchell and seconded by Dr. Lindsey to approve the \$113.02 increase on Line #24 of Bid #902, making the new total \$39,613.99, and approve the minutes of the Regular Meeting held June 30, 2017. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Lindsey, Roberts, and Harris Nay – none

A motion was made by Ms. Mitchell and seconded by Mr. Roberts to approve Claims #1 - #56 totaling \$1,092,965.78 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Roberts, Lindsey, and Harris Nay – none

The Board recognized Mr. Travis Willis who had no report or comments.

The Board recognized Mr. Steve Powell who updated the Board on the mandated Lead and Copper Testing he completed with the assistance of Mr. Don Dunn. They collected twenty (20) samples from eligible sites and delivered them for testing on Wednesday, July 12, 2017. Mr. Powell is expecting favorable test results on Friday, July 21, 2017, which would result in a three year span before another required testing of the system.

Mr. Powell also reported the City of Pryor Creek Asphalt Street Projects are scheduled to begin on South Elliott at Southeast 11th Street and work toward Southeast 17th Street. Mr. Powell met with Mr. Kenny Smith to discuss the shut-off valves effected by the street projects and reported the project would not interfere with any traffic signal loops.

The Board recognized Mr. Gary Pruett who discussed the 2017 MESO (Municipal Electric Systems of Oklahoma) Line Workers Rodeo and Safety Training hosted by Grand River Dam Authority at the Mid-America Industrial Park Expo Center on September 27-28, 2017 and recommended the Board allow six (6) members of the Electric Department to participate in the training at a cost of \$79.00

each. Mr. Pruett believes it would be an excellent experience for our Electric Department to assist with building and preparing the competition field and to serve as support staff during the Line Workers Rodeo.

A motion was made by Dr. Lindsey and seconded by Ms. Mitchell to allow six (6) members of the Electric Department to participate in the 2017 MESO (Municipal Electric Systems of Oklahoma) Line Workers Rodeo and Safety Training hosted by Grand River Dam Authority at the Mid-America Industrial Park Expo Center on September 27-28, 2017, at a cost of \$79.00 each and to assist with building and preparing the competition field and serving as support staff during the Line Workers Rodeo. MOTION CARRIED. Votes cast as follows: Ayes – Lindsey, Mitchell, Roberts, and Harris Nay – none

Mr. Pruett reported the former Assistant General Manager, Mr. Andy Richard, is recovering from a stroke and he plans to visit him during his hospitalization for physical therapy when Mr. Richard is ready to receive visitors.

Mr. Pruett reported Mr. Bill Cowan is retiring after 21½ years of dedicated service to the Municipal Utility Board and the Citizens of Pryor Creek. Mr. Pruett invited the Board Members to attend an appreciation picnic lunch at the MUB Warehouse to be held in his honor at noon on Friday, July 21, 2017.

The Board recognized Mr. Jared Crisp who reported he attended a State Legislative Forum on Friday, July 14, 2017, which was hosted by Grand Lake Association and Grand River Dam Authority at Shangri-La on Grand Lake.

Mr. Crisp also reported on the installation of new utility lines for the Pryor Public School Building Projects at the High School and the new Vocational Agricultural Building.

Mr. Crisp reported he has met with several parties interested in developing new duplexes to be served by the Municipal Utility Board.

Mr. Crisp reported a meeting was arranged by Mayes County's Legal Counsel through Legal Counsel for the Municipal Utility Board regarding water service to the Mayes County Fairgrounds and is scheduled at 9:30 a.m. on July 18, 2017, in the Municipal Utility Board Room.

The Board recognized Mrs. Teri Hill who had no business to report.

A written Department Foreman's Report was presented with no additional comments.

The Board recognized Mr. Pruett who discussed and recommended the promotion of Mr. Travis Willis to Electric Department Foreman Non-Merit, effective July 13, 2017.

A motion was made by Dr. Lindsey and seconded by Ms. Mitchell to promote Mr. Travis Willis to Electric Department Foreman Non-Merit (\$30.94 per hour to \$31.98 per hour), effective July 13, 2017. MOTION CARRIED. Votes cast as follows: Ayes – Lindsey, Mitchell, Roberts, and Harris Nay – none

The Board recognized Mr. Pruett who discussed and conceded to the recommendations from Mr. Jared Crisp and Mr. Travis Willis to re-classify Mr. James Cox to a Groundman on the Electric Crew during the remainder of his probationary period, effective July 13, 2017.

A motion was made by Dr. Lindsey and seconded by Mr. Roberts to re-classify Mr. James Cox to a Groundman on the Electric Crew during the remainder of his probationary period (\$18.35 per hour to \$20.44 per hour), effective July 13, 2017. MOTION CARRIED. Votes cast as follows: Ayes – Lindsey, Roberts, Mitchell, and Harris Nay – none

Mr. Pruett reported the promotion of Mr. Willis and the reclassification of Mr. Cox will create an opening for a Journeyman Lineman and an opening in the Tree-Trimming Crew. He also has an opening in the Gas Department due to the resignation of Mr. Andrew Holman. If Mr. Cox proves worthy of management's expectations, the plan is to enroll Mr. Cox in the MESO (Municipal Electric Systems of Oklahoma) Basic Lineman Apprentice School so he can work his way to Journeyman.

The Board recognized Mr. Pruett who discussed and recommended the promotion of Mr. Spencer Steffey to "B" Mechanic Non-Merit in the Natural Gas Department, effective July 13, 2017.

A motion was made by Ms. Mitchell and seconded by Mr. Roberts to promote Mr. Spencer Steffey to "B" Mechanic Non-Merit in the Natural Gas Department (\$20.13 per hour to \$20.44 per hour), effective July 13, 2017. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Roberts, Lindsey, and Harris Nay – none

There was no unfinished or new business discussed.

The Board recognized Mr. Fred Sordahl who had no report.

A motion was made by Mr. Roberts and seconded by Ms. Mitchell to adjourn at 7:40 o'clock p.m. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Mitchell, Lindsey, and Harris Nay – none
