

February 5, 2018

The Municipal Utility Board met in a Regular Session at 7:00 o'clock p.m. on Monday, February 5, 2018, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Ms. Lorri Mitchell Dr. Ken Rains, Mr. Mark Roberts, and Dr. Art Sixkiller.

A motion was made by Mr. Roberts and seconded by Dr. Rains to approve the minutes of the Regular Meeting held January 16, 2018. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Rains, Sixkiller, Mitchell, and Harris Nay – none

A motion was made Mr. Roberts and seconded by Ms. Mitchell to approve Claims #738 - #811 totaling \$380,311.90 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Mitchell, Sixkiller, Rains, and Harris Nay – none

The Board recognized Mayor Tramel who had no report.

The Board recognized Ms. Laura Townsend, the Grand River Dam Authority Marketing Programs/Community Relations Department Manager, who presented a \$9,000.00 check to the Municipal Utility Board for the City of Pryor Creek Main Street light beautification project.

The Board recognized Mr. Steve Powell who reported the survey and evaluations for the warehouse parking lot repair project is ready for review by Staff. Mr. Powell also gave progress reports on the sludge removal project at the Wastewater Treatment Plant and the utility easement project across the Corps of Engineers property along the north side of SE 49th Street situated between Oakwood Drive and Elliott Street.

The Board recognized Mr. Gary Pruett who reported the Pryor Creek City Council approved MUB's recommendation of increasing the residential water rates inside the corporate city limits of Pryor Creek due to the \$0.14 cost increase from Oklahoma Ordnance Works Authority (OOWA). Mr. Pruett recommended the Board increase the Inside City Limit Water Rate minimum and first 2,000 gallons to \$8.78 and \$4.39 per 1,000 gallons on all additional usage effective February Billing due March 1, 2018.

A motion was made by Mr. Roberts and approved by Dr. Sixkiller to increase the Inside City Limit Water Rate minimum and first 2,000 gallons to \$8.78 and \$4.39 per 1,000 gallons on all additional usage effective February Billing due March 1, 2018. Mr. Pruett discussed the benefits to the Wastewater Superintendent Mr. Mike Peters and the Water Department Foreman Mr. Kenny Smith if they are allowed to attend the Oklahoma Rural Water Association Annual Technical Conference at the Embassy Suites Hotel/Conference Center in Norman, Oklahoma on April 16-18, 2018 at a total cost not to exceed \$1,000.00.

A motion was made by Dr. Rains and seconded by Mr. Roberts to allow Mr. Mike Peters and Mr. Kenny Smith to attend the Oklahoma Rural Water Association Annual Technical Conference at the Embassy Suites Hotel/Conference Center in Norman, Oklahoma on April 16-18, 2018 at a total cost not to exceed \$1,000.00. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Mitchell, Sixkiller, and Harris Nay – none

The Board recognized Mr. Jared Crisp who reported he has been preparing the required annual gas and electric reports for the United States Energy Department. He also reported he is gathering data on the traffic signals along U.S. Highway 69 in search of a solution to the glare issues.

Mr. Crisp discussed the ½ sales tax origin and major expenses paid by the sales tax since the 1990's. Mr. Crisp would like to share a memo prepared by Mr. Pruett and himself with the Mayor and City of Pryor Creek Council Members. The Board gave their blessing to share the memo and make it public.

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

There was no unfinished or new business to discuss.

The Board recognized Mr. Ben Sherrer who had no report.
