

May 6, 2019

The Municipal Utility Board met in a Regular Session at 7:00 p.m. on Monday, May 6, 2019, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Mr. Mark Roberts, and Dr. Art Sixkiller.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held April 15, 2019. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Sixkiller, Mitchell, and Harris. Nay – none

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #1207 - #1294 totaling \$898,367.90 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Roberts, Rains, and Harris Nay – none

The Board recognized Mayor Lees who expressed no update report from Mid-America Industrial Park regarding "The District" annexation process and their goal to present a Resolution during the First Council Meeting in May 2019.

The Board recognized Mr. Jared Crisp who reported Mr. Powell had a schedule conflict that prevented his attendance. Mr. Crisp reported the Kum & Go Project is still on hold and our crews began the extensions of the gas and water service loop on Southeast 49<sup>th</sup> Street but the project was halted by the weather. Staff continues to work with Mr. Powell on the Wastewater Treatment Plant Analysis.

Mr. Jared Crisp discussed the hiring of Mr. Kenneth Young by the City of Pryor Creek as a full time certified building inspector. Mr. Young received five (5) residential certifications requested by the City and has started working on obtaining his commercial certifications.

Mr. Crisp reported the Municipal Utility Board Budget included \$25,000 annually to cost share the position once the city hired a Certified Building Inspector. Mr. Crisp recommended the Municipal Utility Board add \$2,100.00 monthly (\$25,200.00 annually) to the current monthly allocation payments (\$750,000.00 annually) to the City of Pryor and if the certified building inspector left that position for any reason, the \$2,100.00 additional monthly amount would be removed. If the Board approved the recommendation, then the Municipal Utility Board monthly allocation to the City with a certified building inspector would be \$64,600.00 (\$775,200.00 annually). Two (2) monthly payment would be included in FY2018-2019.

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to add \$2,100.00 monthly (\$25,200.00 annually) to the current monthly allocation payments (\$750,000.00 annually) to the

City of Pryor and if the certified building inspector left that position for any reason, the \$2,100.00 additional monthly amount would be removed. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Roberts, Rains, Mitchell, and Harris Nay – none

Mr. Jared Crisp recognized Pryor Main Street Inc. representatives Mr. Scott Miller and Ms. Jennie VanBuskirk who made a request to provide enhancements to the downtown ornamental light poles. Mr. Crisp discussed the Voluntary Release and Waiver of Liability prepared by our legal counsel, Mr. Fred Sordahl. Mr. Crisp recommended to the Board to allow Pryor Main Street Inc. to paint the downtown ornamental light poles as long as all volunteers signed the Voluntary Release and Waiver of Liability form. Mr. Crisp also recommended the Board purchase one set of the requested brackets to be installed by the electric crew on one pole and install a banner as a trial and prepare a Memorandum of Understanding before making any recommendations to allow banners on the ornamental light poles.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to allow Pryor Main Street Inc. to paint the downtown ornamental light poles and to purchase one set of the requested brackets to be installed by the electric crew on one pole then install a banner as a trial and prepare a Memorandum of Understanding. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Rains, Roberts, and Harris Nay – none

Mr. Crisp discussed and recommended the approval of the First Amendment to our Power Purchase and Sale Agreement with the Grand River Dam Authority which includes new language that clarifies needed contract updates and defines more clearly the installation/powering and retail use of Electric Vehicle chargers.
