

## December 16, 2019

The Municipal Utility Board met in a Regular Session at 7:02 p.m. on Monday, December 16, 2019, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Art Sixkiller, Dr. Ken Rains, and Mr. Mark Roberts.

Guest attending were: Honorable Mayor Lees, Mr. Terry Aylward, Mr. Jeff Kolker, and Ms. Violet Kirkendall.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held December 2, 2019. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, and Harris. Dr. Sixkiller abstained and counted as no vote.

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to approve Claims #630 - #693 totaling \$846,821.66 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Roberts, Rains, and Harris Nay – none

The Board recognized Honorable Mayor Lees who reported the Holiday Spirit and Sales Tax were strong this season. The Mayor also reported the MidAmerica Park petitioned the City of Pryor for annexation of "The District" development. The petition will be presented during the December 17, 2019 Regular Scheduled Pryor Creek City Council Meeting.

The Board recognized Ms. Violet F. Kirkendall of Hood & Associates CPAs, PC who presented the Annual Audit for Fiscal Year ending June 30, 2019 with a Total net position of \$37,875,017 and no current year audit findings. Mr. Crisp added the Municipal Utility Board was able to increase the unrestricted cash reserve to \$2,539,663 by order of the City Charter. However, the excess profit of \$198,886.12 would be presented to the City of Pryor Creek after Board approval of the Fiscal Year Audit ending June 30, 2019. The excess profit was due to a few capital improvement projects (a.k.a. Kum-n-Go) that were put on hold and the unfilled positions for an Assistant to the General Manager and an Electric Journeyman Lineman.

Mr. Ben Sherrer, MUB Legal Counsel, reported the December 16, 2019 Agenda did not include an item for the Board to take action on the Audit for Fiscal Year ending June 30, 2019.

The Board recognized Mr. Steve Powell who reported he has been preparing quotes on the replacement of the guide rails and controls for the pumps at the 9<sup>th</sup> Street Lift Station. Mr. Powell reported he anticipates five (5) contractors to participate in the December 30, 2019 bid opening, regarding the Westside Water Project and bore under State Highway 20.

Mr. Powell reported on his plan to conduct a Public Hearing after the first of the year (January 1, 2020) for the residents effected by the North Old Airport and North 4323 water and gas extensions.

Mr. Powell also reported on the revised application to the Mayes County Commissioners to re-locate a gas line on the west side of Oakwood Road instead of the east side.

The Board recognized Mr. Jared Crisp who discussed the annexation of "The District" and a revision to their Memorandum of Understanding. Mr. Crisp recommended the Board authorize him (the General Manager) to sign the amended Memorandum of Understanding regarding MidAmerica Industrial Park/City of Pryor Creek for "The District".

A motion was made by Ms. Mitchell and seconded by Dr. Sixkiller to authorize the General Manager (Mr. Jared Crisp) to sign the amended Memorandum of Understanding regarding MidAmerica Industrial Park/City of Pryor Creek for "The District". MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Sixkiller, Roberts, Rains, and Harris Nay – none

Mr. Crisp reported he would be attending the December 17, 2019 Pryor Creek City Council Meeting to report the Municipal Utility Board's excess profit of \$198,886.12 which would be presented to the City of Pryor Creek after Board approval of the Fiscal Year Audit ending June 30, 2019 and to support Agenda Item 5a (Discussion and possible action concerning the current proposed revised MOU among the City of Pryor Creek, Pryor Municipal Utility Board and MAIP/OOWA regarding proposed annexation of property known as "The District").

Mr. Crisp discussed the gas and oil industries low prices and the possibility of locking in our natural gas rates with BlueMark Energy.

A motion was made by Dr. Rains and seconded by Dr. Sixkiller to authorize the General Manager (Mr. Jared Crisp) to negotiate a July 2020 to June 2021 contract to lock-in our wholesale natural gas pricing at \$2.50 or less per MMBtu for a twelve (12) month period with BlueMark Energy. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Sixkiller, Mitchell, Roberts, and Harris Nay – none

Mr. Crisp discussed the coded welder's incentive and the need to maintain two (2) coded welders in the natural gas department. Mr. Crisp recommended the Board adjust the coded welder's incentive from \$0.25 per hour to \$1.00 per hour contingent on passing the annual test requirements in a timely manner.

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to increase the coded welder incentive from \$0.25 per hour to \$1.00 per hour contingent on passing the annual test requirements. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Rains, Mitchell, and Harris Nay – none

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with comments from Mr. Jared Crisp.

Mr. Jared Crisp discussed Bid #924 (Electric Department Material) and recommended the Best Lead Time Bid and reasonable quote from Anixter in the amount of \$32,822.00.

A motion was made by Ms. Mitchell and seconded by Mr. Roberts to award Bid #924 (Electric Department Material) to Anixter who had the best lead time and a reasonable quote of \$32,822.00. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Roberts, Rains, Sixkiller, and Harris Nay – none

Mr. Jared Crisp discussed and recommended the promotion of Mr. Travis Berka to "B" Mechanic with Merit, effective December 12, 2019.

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to promote Mr. Travis Berka to "B" Mechanic with Merit (\$21.90 per hour to \$22.39 per hour), effective December 12, 2019. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Mitchell, Roberts, and Harris Nay – none

Mr. Jared Crisp discussed and recommended the re-classification of Mr. Kenneth Bryce Kerns to a Regular Employee with the promotion to Apprentice Lineman 3<sup>rd</sup> Year with Merit, effective December 12, 2019.

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to reclassify Mr. Kenneth Bryce Kerns to a Regular Employee with the promotion to Apprentice Lineman 3<sup>rd</sup> Year with Merit (\$25.70 per hour to \$28.49 per hour), effective December 12, 2019. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Roberts, Mitchell, and Harris Nay – none

There was no unfinished or new business to discuss.

The Board recognized Mr. Ben Sherrer who had no report.

A motion was made by Ms. Mitchell and seconded by Mr. Roberts to adjourn at 8:06 p.m. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Roberts, Rains, Sixkiller, and Harris Nay – none
