

September 7, 2021

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Tuesday, September 7, 2021, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Ms. Lorri Mitchell, Mr. Mark Roberts, Dr. Art Sixkiller, and Dr. Ken Rains.

Also attending were Mr. Ryan Stout, Mr. Travis Willis, and Mr. Dalton Powell.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held August 16, 2021. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Mitchell, Sixkiller, and Harris.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #169 - #253 totaling \$805,197.81 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Rains, Roberts, and Harris Nay – none

The Board recognized Mr. Steve Powell who updated the Board on the Hydraulic Analysis testing and discussed a few minor issues with moving the controls to the N. Elliott St. water tower. His staff will be working with MUB's staff to determine a solution and will present to the board at a later date.

Mr. Powell reported the Giles Sewer Interceptor Extension Project is eighty (80%) percent complete and Mr. Crisp added a preconstruction meeting had been scheduled for next week with the approved Contractor (Bates Infrastructure, LLC) on the US69 Highway Water Project between Park Street and Southeast 5th Street (PMUB-21-02).

The Board recognized Mr. Jared Crisp who reported the presentation of the AMI (Advanced Metering Infrastructure) during the 2021 Hometown Connections Inc. Annual Conference in Fort Collins, Colorado was informative and he will be attending more AMI discussions with the Grand River Dam Authority (GRDA) Executive Team.

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

Mr. Crisp discussed and recommended the reclassification of Mr. Dayton Brown, 2nd Year Apprentice Non-Merit Probationary Employee, to a Regular Employee with no promotion, effective September 3, 2021.

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to reclassify Mr. Dayton Brown from a Probationary Employee to a Regular Employee, effective September 3, 2021. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Roberts, Rains, Mitchell, and Harris Nay – none
